# Why are range barriers important?

#### **Herd Management & Range Stewardship**

#### If impacted, this can lead to....

- a decline in rangeland health
- increased costs to retrieve livestock
- unplanned livestock breeding
- non-compliance with RUP or practice requirements



# What does FRPA require?

- Applies to forest licensees required to have a FSP/WLP (what about holders of FLTCs?)
- Propose measures in an operational plan
- Carry out those measures
- Requirement to mitigate continues even after plan expires / licence holder removed from plan

- 10 case studies in 9 FLNR districts
- were the steps in mitigation effective?

### **Measures in Operational Plans**

- 46 FSPs and 10 WLPs
- likely to lead to effective mitigation?
- are they verifiable (enforceable)?

#### Measures in 56 FSPs & WLPs

If the measure in the plan is followed as written, would it likely to result in good mitigation?

YES	NO
39	17

For the 17 plans, it does not mean that there <u>will</u> be problems with how mitigation is done.



## Are the measures enforceable?

Verifiability (Enforceability)	56 Plans	
Verifiable	1	
Partially verifiable	31	
Not verifiable	24	

- Use of terms like consider, reasonable compromise, reasonable efforts
- No timeframe for mitigation



## **Factors Limiting Effective Mitigation**

- Issues with the stumpage appraisal system
- Lack of proactive forest planning
- Poor information on location of range barriers
- Cumulative harvesting & other land uses
- Cost-sharing arrangements
- Issues with guidance on managing range barriers



### What did the Board recommend?

- Ensure measures in operational plans will likely be effective and are verifiable.
- Improve policies governing stumpage appraisal related to range barrier mitigation (more flexibility is required).
- Improve guidance on range barrier mitigation (e.g. what values is government intending to protect?).
